STRAWBERRY SHOWDOWN CULINARY CONTEST RULES

1. Contestants may submit up to three (3) different strawberry themed entries.
2. Each recipe must contain enough of the culinary creation for a panel of up to four judges to each taste.
3. Each entry must be clearly labeled and include a complete ingredient list on a 3" x 5" card with the name of the culinary dish and contestant name.
4. All contest entries may be dropped off Thursday, June 6, 2019 from noon - 8 p.m. or Friday, June 7, 2018 from 8 - 11 a.m. at the Jan Dempsey Community Arts Center. All contest entries become the property of the Auburn Arts Association and will be available for public sampling during the SummerNight Downtown Art Walk.
5. Each entry must be original and contain at least **1/2 cup of strawberries**.
6. Each entry will be judged on the following criteria: **TASTE, CREATIVITY AND PRESENTATION**.
 - All contest entries must be homemade, no commercial entries will be accepted.
 - All entries must be in a disposable container. The SummerNight committee is not responsible for the return of any non-disposable containers.
7. The decision of the judges is final. Judges will not know participants' names.
8. Winners will be announced at 7:15 p.m. on the main stage during SummerNight.
9. If you are a winner, you give your permission to have your photo taken and have it used for SummerNight promotional materials.
